AIMS comments

The AIMS Games were extremely successful. The majority of students behaved very well and represented the school in line with all our school values. There was one minor behavior incident involving two boys getting into a pushing situation whilst at the football house. As a consequence, the two students were moved to the teacher's house for the evening.

The competition was very challenging. Our players performed admirably but had to come to terms with not being the top-performing school. Netball finished 85th. Football achieved one win and a couple of draws. Basketball had one win. In individual events, one student finished fourth in BMX and placed in the 30s in mountain biking. Our badminton players reached division two in singles and division four in doubles, winning division four. Our swimmer performed exceptionally well, achieving personal best times.

Looking to the future:

- We will consult with the community earlier regarding teams attending the AIMS Games.
- Teachers will stay in the houses with the teams to support behavior management and provide guidance.
- Fundraising will be run as a school-based initiative rather than team-based efforts.

A big thank you to all staff and parents who contributed to making this opportunity available for our students. This initiative to attend the AIMS Games was introduced to help us compete with intermediate schools and retain our students. Since its inception, our Year 7 and 8 cohort has grown from 44 students to over 150, making this a highly successful addition to our school.
